ITEMS TO BE PROVIDED BY EPSCO COMPANY (HONG KONG) LIMITED ("EPSCO") ON COMPLIMENTARY BASIS 易辦事(香港)有限公司(下稱“本公司”)免費提供之項目(下統稱“有關服務”)

1. Delivery and installation of EPSCO-issued point of sale terminals ("POS Terminals") 運送及安裝「易辦事」終端機(下稱“終端機”)
2. Maintenance of POS terminals 終端機之維修及保養
3. Removal of EPSCO-issued POS terminals from installation premises on termination 因取消服務而收回終端機
4. Promotion label and stand 宣傳用之貼紙及膠座
5. Training Course as EPSCO shall consider appropriate 本公司認為適合的訓練課程

ITEMS TO BE BORNE OR PAID BY MERCHANT 商戶支付之項目

1. Cost of site preparation at Merchant's designated location(s) including application for a telephone line and 13M socket. (Please make sure that the existing telephone line is a normal line without any special function.) 商戶裝置終端機地點之準備工程，包括申請電紋線及準備13M電源插座。
2. The Merchant shall pay to EPSCO (i) a communication fee; (ii) a transaction commission at the rate of 1% on value of the transactions subject to a minimum charge of HKD500 per terminal per event. 商戶須向本公司支付(i)通訊費，(ii)交易佣金；收費率為該交易金額之1%，但最低收費為每次展覽每部終端機港幣500元。
3. A deposit of HKD5,000 per POS terminal is required to be paid to EPSCO and will only be refunded upon the collection of the POS terminal after the Event and subject to all outstanding charges and claims for POS terminal damages are settled. 每部終端機之按金為港幣5,000元，此按金在展覽完畢後，本公司收回終端機及扣除所有費用或損壞之賠償後，始發還給商戶。
4. For any Event which lasts for more than 1 month, the Merchant should apply for an "Extension Permit" 7 working days prior to the Services being terminated. An addition HKD5,000 deposit per POS terminal per event should be paid to EPSCO otherwise the Services will be terminated. 如展覽期超過一個月，商戶必須在展覽期完結前七個工作天向本公司申請“延期許可證”本公司將收取每部終端機港幣5,000元之附加按金。如商戶未能繳交有關的附加按金，本公司將停止有關服務。
5. Printing paper 終端機所用的打印收條。
6. For new application, cancellation of the Services by the Merchant, prior to the installation of the POS terminal or activation of the Services, will be subject to an administration charge of HKD500 per POS terminal. 商戶在簽妥「易辦事」申請表後而在終端機安裝或啟動之前提出取消申請事宜，均須根據每部申請的終端機繳付港幣500元之行政費用。
7. Charges payable by the Merchant should be made within 3 days of the date of the invoice sent by EPSCO to the Merchant. The Merchant shall pay interest on any amount in default at the rate of one percent per month or part of a month from the due date of payment until the actual date of payment (as well after as before judgment). 本公司寄出之賬單必須於賬單日期三天內繳交，本公司將向任何拖欠賬單徵收每月百分之一之利息，直到拖欠賬單被繳付為止(不論在法院裁決前或後)。
8. In case of discrepancies between the English and Chinese versions, the English version shall apply and prevail. 中英文本如有歧義，須以英文本為準。
9. These Terms and Conditions shall be governed by and construed in accordance with the laws of the Hong Kong SAR and EPSCO and the Merchant hereby submit to the non-exclusive jurisdiction of the Hong Kong SAR courts. 本條款受香港特別行政區法律所管轄，並按其詮釋，本公司及商戶同意提呈有關本條款之爭議予香港特別行政區法院審議。
