#### Limited Company

1. Business Registration Certificate
2. Certificate of Incorporation
3. Company Registry: Form NC1/ AR/ D2 (if applicable)
4. Hong Kong Identity Card/ Passport of all directors
5. Company Bank Account Pay-in slip/ Statement
6. Minutes of Meeting

### EPS Installation Services

#### Services provided by EPS Company

- Delivery and installation of EPS Company-issued POS terminals
- Maintenance of EPS Company - issued POS terminals
- Removal of EPS Company - issued POS terminals from installation premises upon services termination
- Promotion label and stand
- User training

#### Merchant's responsibilities

- Setup of telephone line (a normal line without any special function)/ broadband access and a 13M socket should be prepared at terminal installation site
- Debit card transaction fee with monthly minimum charge (whichever is higher)
- Monthly communication fee on terminal basis
- Sales slip
- If the EPS Service application is cancelled within 180 days from terminal installation date, an early return charge per terminal shall be levied
- A deposit shall be placed and will only be refunded after the agreement termination, subject to all outstanding charges and liabilities are settled (written notice of termination must be made at least 30 days in advance)
- For new merchant application, cancellation of the signed EPS Merchant Agreement by the merchant, prior to the installation of the terminal or activation of the service, will be subject to an administration charge per terminal

### Other Business

In addition to EPS Service, EPS Company provides various payment services:

#### PPS

PPS is jointly provided by EPS Company and Hong Kong Telecommunications (HK) Limited. After registration, Users can pay over 900 bills via telephone, PPS App, or [www.ppshk.com](http://www.ppshk.com) anytime, anywhere. PPS is widely accepted by users and merchants, covering almost every part of business sectors, including public utilities, government departments, telecommunication services, credit cards, educational institutions and charity organizations.



#### PPS Shop&Buy

Riding on the existing PPS infrastructure, a secure debit payment gateway PPS Shop&Buy is introduced. It allows direct integration with merchants' web applications, thereby enabling them to offer a secure and cost-effective internet payment option with real-time acknowledgement. Merchants having transaction-capable websites such as securities trading firms, travel agents, retailers and other internet portals can benefit from the simplicity and convenience of PPS Shop&Buy, allowing them to generate revenue for their online business.

#### Over-the-counter Bill Payment Service

EPS Company and Circle K Convenience Stores/ CRVanguard jointly offer Over-the-counter Bill Payment Service in which Customers can pay hundreds of bills at any Convenience Store/ Superstore shop\*. Upon presenting the bill with printed barcode at the retail counter, Customer can pay the bill by cash and obtain a receipt as reference.

*\*Excluding Convenience Stores & Superstore/ shop in Mainland China and Macau*

#### China UnionPay (CUP) Service

CUP cards are issued by local financial institutions in Mainland China and overseas member banks. Every valid CUP card bears the UnionPay logo can be used in all retail outlets.



From now on, EPS merchants can accept CUP card transactions through their EPS point of sale terminals. Funds will be credited to their designated bank accounts on the following working day after the transaction day.
